# SECTION 1: BACKGROUND, OVERVIEW AND RFP SCOPE OF REQUIREMENTS

#### 1. INTRODUCTION

The National Lotteries Commission was established in terms of the Lotteries Act No. 57 of 1997, as amended (Lotteries Act) to regulate the National Lottery as well as other lotteries and societies.

The NLC aims to ensure that funds raised through the National Lottery are distributed equitably and expeditiously across South Africa in order to advance social upliftment of communities in need with theaim of addressing poverty and reducing inequalities in line with the National Development Plan.

The Commission is required to apply principles of openness and transparency in the exercise of its functions assigned to it in terms of the Lotteries Act No 57 of 1997.

### 2. BACKGROUND

PFMA S(51)(1)(a) requires that "An accounting authority for a public entity must ensure that that publicentity has and maintains effective, efficient and transparent systems of financial and risk management and internal control. In line with the requirements of the Public Finance Management Act No. 1 of 1999("PFMA") and Treasury Regulations, the NLC seeks to appoint professional and advisory services for enterprise risk management to form part of a panel for a period of three years.

#### 3. PURPOSE

National Lotteries Commission's Risk Division has identified a need to augment or supplement its current capacity by establishing a panel of service providers. The panel of successful bidders will provide a variety of Risk related activities. The specialized professional services will be sought on an "as and when "required basis with the guidance of rotational strategy.

#### 4. SCOPE OF WORK

- Conduct Strategic risk assessments for the NLC, NLPT and the Lottery Operator as a minimum and as and when required
- Conduct Operational risk assessments for the NLC divisions, provincial offices and subsidiaries
- Analysis of risk information
- Setting and reviewing risk appetite and tolerance levels
- Design and development of Risk reports that appeal to various stakeholders
- Develop and review Enterprise Risk Management (ERM) governance documents (e.g. policies, frameworks and relevant reporting templates
- Risk Management training, certification, awareness and marketing campaigns
- Conduct a comprehensive risk maturity assessment for NLC, which encompasses developing tools and techniques, evaluating the current risk maturity level, identifying areas of success and challenges, and recommending enhancements to achieve the next maturity level
- · Any other Risk related services

### 5. DELIVERABLES

- Strategic and Operational Risk Assessments: Provide report with recommended mitigation strategies.
- Revised and updated Risk Management Policy and Risk Management Framework of the organization.

- Risk Training and Awareness and marketing campaigns.
- The service provider shall deliver two key outputs:
  - A risk maturity assessment questionnaire and a comprehensive report outlining ERM successes/challenges and recommendations for enhancement and improvement.
- Risk Management Services: Provide any other Risk related services.

### 6. DURATION OF THE PROJECT

• The expected duration of the project is for a period of 3 years from the date of signing of the service level agreement (SLA).

# **SECTION 2: NOTICE TO BIDDERS**

- 1.6 This RFP will be evaluated in terms of the 80/20 preference point system.
- 1.7 Suppliers are required to register on the Central Supplier Database at <a href="www.csd.gov.za">www.csd.gov.za</a>.
- 1.8 Suppliers must provide their CSD registration number (and attach a CSD Registration report)and ensure that their tax matters are compliant.

# 2. General rules and instructions

- 2.1 News and press releases
- 2.1.1 Bidders or their agents shall not make any news releases concerning this RFP or the awarding of the same or any resulting agreement(s) without the consent of, and then only in co- ordination with, the NLC.
- 2.2 Precedence of documents
- 2.2.1 This RFP consists of a number of sections. Where there is a contradiction in terms between the clauses, phrases, words, stipulations, or terms and herein referred to generally as stipulations in this RFP and the stipulations in any other document attached hereto, or the RFP submitted hereto, the relevant stipulations in this RFP shall take precedence.
- 2.2.2 Where this RFP is silent on any matter, the relevant stipulations addressing such matter, andwhich appear in section 217 of the constitution of the republic shall take precedence. Biddersshall refrain from incorporating any additional stipulations in its proposal submitted in terms hereof other than in the form of a clearly marked recommendation that the NLC may in its solediscretion elect to import or to ignore. - 2.7.1 Headings are incorporated into this RFP document and submitted in response thereto, for ease of reference only and shall not form part thereof for any purpose of interpretation or for any other purpose.
- 2.8 Occupational Injuries and Diseases Act 13 of 1993
